Global Enrichment is the Goal

TIDE answers the international call against the global increase of anti-social activities, the woes of urban living, poverty and environmental ruin. TIDE maintains an 8-tiered delivery system, when implemented, expands the intellectual, financial, economic and political interaction within a community.

Each TIDE solution segment compliments the whole, sufficient to remedy the social, economic and environmental ills faced in any global metropolis.

1. Intellectual Sovereignty - Lack of understanding and application keeps vast global populations economically, politically, socially, environmentally

and intellectually impotent, and subservient to poverty and crime. TIDE's sole aim is to inspire a driven society towards applying **intellect** in gaining **sovereignty** from the controls working against them and their descendants.



2. Financial Independence - Applied financial literacy skills are key to establishing individual and community economic independence. TIDE communities and residents are empowered by financial mentors to understand, interact with and hone the financial and economic landscape for their best interest.

3. Chivalrous Mentoring - The absence of community engagement and leadership for community youth has resulted in plunging property across the globe. TIDE's mentoring programs assure willing communities benefit from the knowledge, skill, ability, and experience supplied by mentors.¹ Coaching techniques administered to young adults builds human capital in the community, which will end the effects of dissidence and community imprisonment.

4. Community Protection/Security Operations (CPSO) - TIDE incorporates multi-faceted CPSO programs to establish safety boundaries

using residential enabling, Tactical Team training and advanced security systems. Effective assessment & response protocols assure personal and property protection restoring our diverse communities into civil societies.²

5. Healthy Lifestyle - Health disparities in disadvantaged communities are well documented and reversible. TIDE fulfills the need, recovering communities through programs including; (1) access to healthy foods; (2)
